

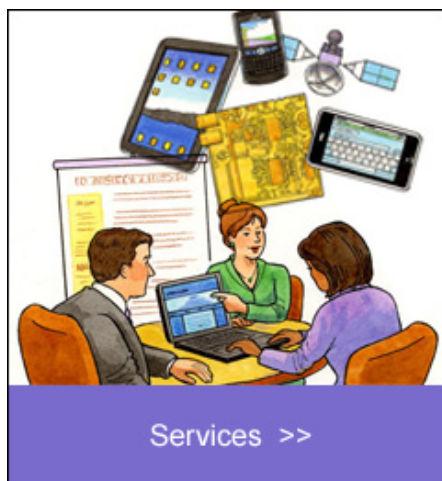

In 2015, the agency was ranked among the top three firms for **Integrated Law Firm Marketing**.

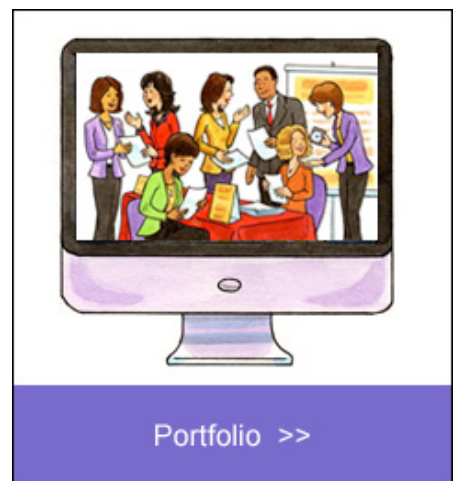
